## SCHOOL POLICY

- Enrollment:** Enrollment in a course entails payment of the equivalent of one month's fee for the chosen course. This will be used as the payment for June.
- Monthly Payments:** The monthly fee for any course must be paid within the first five days of the current month.
- School Reinforcement Courses:** These courses will take place from September 1 to June 30.
- Minimum Students:** The Center reserves the right to discontinue any course if the number of students does not reach the minimum required for its viability (five people).
- Attendance and Renewal:** Attendance to a course must respect the established schedule, group, and reservation. Students wishing to continue beyond June must renew their enrollment and confirm participation in the new course by paying a reservation fee in June. Failure to do so may result in the Center offering the place to someone else.
- Commitment to Attendance and Payment:** School support and English courses run from September 1 to June 30. Reserving a spot implies a commitment to attendance and payment throughout the entire course, regardless of the student's attendance. Absence for a month without payment will not be allowed, as the spot will remain exclusively reserved for the student. If a student decides to discontinue the course before June, the enrollment fee will be forfeited.
- Policy on In-Person and Online Classes:** If, due to force majeure related to administrative or external provisions, we are unable to hold in-person classes at the center, they will be conducted online. In this case, the inability to attend the class online does not exempt the client from their payment obligation. Therefore, if the client decides not to attend the scheduled online class, it will not be refunded or rescheduled.  
We appreciate your understanding and cooperation in unforeseen circumstances beyond our control.
- Private Classes:**
  - These must be paid in advance between the 1st and 5th of each month in a single monthly payment.
  - Hours missed due to the student's absence will not be rescheduled unless at least 24 hours' notice is provided. In this case, rescheduling will only be possible during available times.
  - If the student wishes to reduce the number of agreed hours for the current or following month, the fee will be adjusted to reflect the new number of hours. The applied rate will correspond to the effective number of hours the student decides to take, with no refund for unused hours. Furthermore, reducing the number of hours may result in the unavailability of the same hours in subsequent months.
- Schedule:** Winter and summer schedules will differ, as ÓPTIMUS is closed in the afternoons during July and August. The same applies to Christmas, Semana Blanca, and Easter.
